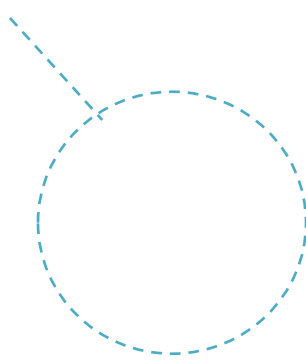




# Drought Emergency Update

**Stage 3—Water Shortage Emergency.** The following regulations shall be applicable to all customers of the MHCSD's water system:

1. Residential Accounts. Residential accounts shall use no more than eighty (80) percent of the quantity of water delivered to the customer's property as recorded by meter during the corresponding billing period of the base year. Notwithstanding this provision, no residential account shall receive an allocation of less than six hundred (600) cubic feet (6CCF) of water per billing period.
2. Multiple-Family Residential Accounts. Multiple-family residences, which are served by a single meter, shall use no more than eighty (80) percent of the total quantity of water delivered to the customer's property as recorded by the meter during the corresponding billing period during the base year. Notwithstanding this provision, no multiple-family residential account shall receive a monthly allocation of less than four hundred (400) cubic feet (4CCF) of water per unit served on a single meter.
3. Nonresidential Accounts. Nonresidential accounts shall use no more than eighty (80) percent of the quantity of water delivered to the customer's property as recorded by meter during the corresponding billing period of the base year.
4. Process-Water User Accounts. Process-water users shall use no more than ninety (90) percent of the quantity of water as recorded by meter during the corresponding billing period during the base year.
5. Construction Water. All existing potable water uses for construction purposes shall be cut back by fifty (50) percent. The General Manager shall reject all new requests for potable water for construction.
6. Aesthetic Water Features. The supply of potable water for aesthetic water uses shall be cut back by fifty (50) percent. Potable water to ornamental fountains shall be turned off.



WHEREAS on June 25, 2014, the Mountain House Community Services District Board of Directors conducted a public hearing in accordance with MHCSD Ordinance MH-5-3502 for the purpose of determining whether to increase the water shortage emergency to a Stage 3 Water Shortage Emergency which would require a 20% reduction in MHCSD water users use,

THEREFORE, the Board of Directors of the Mountain House Community Services District does ordain as follows:

**Section 1.** Section MH-5-3503(c) of Chapter MH-4.5 of Division 3 to Title 5 of the Ordinance Code of the Mountain House Community Services District is amended to read in its entirety as follows:

“(c) Irrigation of all exterior landscaping including, but not limited to, turf areas, open ground, crops, trees, grass, lawn, ground cover, shrubbery, or decorative plantings using an irrigation system, hose, or outdoor potable water faucet shall be allowed only on 1) Sundays, Wednesdays and Fridays between the hours of 9:00 p.m. and 6:00 a.m. for properties with an odd numbered street address and 1) Tuesdays, Thursdays and Saturdays between the hours of 9:00 p.m. and 6:00 a.m. for properties with an even numbered street address”.

**Allowed water times in MH during drought – Even and Odd street addresses**  
 You can water your lawn during the green highlighted times if your street address ends in an even number, or the blue times if it ends in an odd number.

With regards to the Water Fountain at Central Community Park, and the Fountain at Town Hall, the fountains use recirculated water at all times with very minimal evaporation. Should the Board of Directors declare a Level 4 Water Emergency Shortage or higher, the fountain would be shut off at that time.
