Thank you for the opportunity to amend our contract to provide construction inspection and startup/commissioning services for the Wastewater Treatment Plant Expansion Project (Project).

Originally, the Project was expected to last 18 months from November 2019 to April 2021. However, this timeline was created prior to hiring the Contractor. Once the Project started in February of 2021, the Contractor provided a revised schedule of 34 months from February 2021 to the end of November 2023.

HDR requests an initial 12-month extension of the contract to the date of September 30, 2022. Additional funds will be necessary to complete the work to November 2023 due to the substantial increase in Project length. HDR plans to request an additional extension with more up to date fees in Q2 of 2022.
